



AUTHORIZATION TO THE PROCESSING OF PERSONAL DATA AND DECLARATION OF SOURCE FUNDS

Dear **CUSTOMER**

With the issuance of law 1581 of 2012 and decree 1377 of 2013, came into force the General Regime of Protection of personal data, which develops the constitutional right that all people have to know, update and rectify all types of information collected or that has been subject to the processing of personal data in banks or databases and general files of public and / or private entities.

In order to comply with this regulation, **COLOMBIA DIVE ADVENTURES SAS**, responsible for the processing of personal data, requests its customers, suppliers and, in general, any natural person whose personal information is in the databases of **COLOMBIA DIVE ADVENTURES SAS**, the authorization to continue with the processing of your personal data in accordance with the privacy policies. The information and personal data provided by you can be used by **COLOMBIA DIVE ADVENTURES SAS**, for the purpose of developing the functions of providing their services, such as consulting, sending information and delivering reports to the vigilance and control authorities and in general for the purposes established in the personal data processing policy.

Consequently and in accordance with the procedures contained in this law, you, as the owner of the information subject to processing, you can exercise your rights to know, update, rectify and delete the data and revoke the authorization. In the terms set forth in Article 10 of Decree 1377 of 2013, **COLOMBIA DIVE ADVENTURES S.A.S** will be expressly authorized to maintain and handle the information provided unless you expressly state otherwise, expressly by any of the aforementioned channels within thirty (30) business days

Likewise, you declare to **COLOMBIA DIVE ADVENTURES S.A.S** in compliance with the requirements set forth in the External Circular No.029 of 2014 issued by the Financial Superintendence of Colombia, in the Organic Statute of the Financial System (Decree 663 of 1993), Decree 2555 of 2010, Law 90 of 1995 and Law 1474 of 2011 "Anticorruption Statute" and other concordant legal norms, that the resources that you manage or your resources come from the following Sources: (occupation, trade, profession, activity, business, etc.)

and that they do not come from any illegal activity of those contemplated in the Colombian Penal Code or in any rule that modifies or adds it. Likewise you will not admit third parties to make deposits on your behalf, with funds coming from illicit activities and you will not carry out transactions destined to such activities in favor of persons related to them. Exempt **COLOMBIA DIVE ADVENTURES S.A.S** of any liability arising from erroneous, false or inaccurate information that you have provided in this document, or from the violation thereof.
